We use cookies, web beacons and similar technologies ("cookies") on this website in order to collect visitor statistics and to improve your experience on this website.

1. What are cookies?

A cookie is a text file placed on your computer, mobile device or tablet by web page servers when you visit websites. Cookies can be stored for varying lengths of time on your device or browser. Some are deleted when you close your browser, and some remain stored until actively deleted or when they reach their expiry date.

We use two types of cookies on our website: session cookies and persistent cookies.

- Session cookies are stored during the period there is an active session, i.e. during the
 period you use the website. Session cookies are normally deleted when you close your
 web browser.
- Persistent cookies are stored on your device until the set expiration date for each cookie or until you manually delete the cookie from your device.

Web beacons are transparent images that may be included in e-mails sent to you.

Similar technologies are technologies that store information in your web browser or on your device in a similar way as cookies and web beacons.

2. Different types of cookies

In addition to session cookies and persistent cookies, cookies are generally divided into first-party cookies and third-party cookies. A first-party cookie is a cookie that is set by the website you are visiting, whereas a third-party cookie is a cookie set by a third-party. We are using both first-party cookies and third-party cookies on this website.

3. Why do we use cookies?

Cookies are used on this website used for the following purposes.

3.1 Statistics

We use cookies to collect visitor statistics in order to get a better understanding of how our website is used.

3.2 Improve your experience

Cookies used for this purpose will enable the website to e.g. store information about your browsing history, in order to improve your experience at the website and provide you with tailored content when appropriate. This is to make your experience on this website as easy as riding Voi.

3.3 Necessary for the website's performance

Data from these cookies enable you to use the website and its features and are necessary in order for the website to function properly.

4. Control the use of cookies

You can generally control your cookie settings by changing the settings on your web browser. Through these settings, you can e.g. block cookies, review the cookies that are used and delete cookies that you do not wish to have stored on your device. If you are not sure about how you find these settings, we recommend that you use the help section of your web browser.

Please note that if you elect to block or delete cookies, your user experience may be adversely affected as some features of the website may be made unavailable as a consequence thereof.

If you elect to not allow the website to store cookies, a cookie will be placed on your device so that the website can remember to not place a cookie on your device when you are browsing. Please note that if you elect to delete all cookies on your device, this cookie will also be deleted, in which case the website will not remember that you have blocked cookies. If you delete all cookies, you will, therefore, have to block cookies once again.
